- **Associate of the Year**
Winner should be actively involved in the local and state home builders associations and their community
- **Remodeler of the Year**
Remodelers engaged in remodeling in the year of the nomination and the year of the award's presentation.

Nominees should have been involved in association projects at the local and state level and active in their community

■ Call for Entries

A BIAW member or local association may submit nominations. Nomination packets shall be received by the BIAW office.

■ Guidelines for Nominations

- A completed Nomination Form must be enclosed.

■ Announcement of Results

Winners of the Builder, Associate and Remodeler of the Year awards will be announced during the BIAW Installation and Awards Ceremony held during the Fall board meeting.
